## **INSTRUCTIONS TO AUTHORS**

Articles (text and illustrations) must be submitted electronically to the editor-in-chief. The text, in .docx, .doc, .odt format, must be treated with Times or Times New Roman font, size 12, double-spaced and unjustified. Articles can be written in French or English.

Title in French and English in small capitals.

Authors' names must be in small capitals, preceded by their first names in full and in lower case, with the full address of the structure to which they are affiliated and the email address.

For collective work, the name of the corresponding author will be specified.

Abstract in French and English not exceeding 350 words.

Keywords in French and English, 5 maximum and in alphabetical order.

Main subtitles will be in small capitals.

Captions of illustrations or tables in the article will be presented in brackets and in abbreviated form (Fig., Pl., Tabl.).

Figures or plates should be sent as separate files in .pdf, .jpeg format with the best possible resolution, the tables in .xlsx, .xls, .ods format. The size of the figures or plates must not exceed 165 mm wide by 240 mm high (on two columns) or 80 mm wide by 240 mm high (on a single column).

The desired location of the illustrations will be indicated by the following, **written in bold red: [Insert here Fig. X (or Tab. Y) on 1 (or 2) column(s)]**

Bibliographic references mentioned in the text must contain the author's name in lowercase in parentheses, without the first name, followed by a comma and the date. Two authors will be united by the sign "&". If there are more than two, we will use "*et al.*" in italic.

The bibliographic list should include all references cited in the text, and only those cited.

References must be presented in alphabetical and chronological order.

Each reference will successively include:

- authors' names in small capitals, followed by the initial of the first name. The "&" sign will be used to connect two author names. If there are more than two authors, their names will be separated by a comma and the "&" sign will be used before the name of the last author.

- the date of publication in brackets or if there are several references from the same author of the same date, this will be followed by a, b, c in the chronological order of publication.

- a period and a dash.

- the title of the contribution.

- for a periodical: its unabbreviated title, in italics, as well as the name of the country or city if they are not an integral part of the title of the periodical. And then the volume and the pagination.

- for a book: the name of the publisher and the city, the number of pages.

- for a thesis or diploma: the name of the university, the number of pages.

In the webography or sitography, the date of consultation of the sites by the author(s) will be specified.

Manuscript that do not conform to the editorial line may be returned.
